



END USER LICENSE AGREEMENT FOR JOOMLA PLUGIN

This End User License Agreement (EULA) is between **you ('either an individual or an entity')** and **Xecurify Inc (DBA miniOrange Security Software Private Limited)**.

PLEASE READ THIS AGREEMENT BEFORE USING ANY **XECURIFY SOFTWARE OR SERVICES**. BY DOWNLOADING, INSTALLING, OR USING ANY **XECURIFY SOFTWARE OR SERVICES** YOU ("the Customer") SIGNIFY ACCEPTANCE OF AND AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT.

"Customer" or "you" agree to the terms of this Agreement. If you are entering into this Agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its Affiliates to this Agreement. 1. GRANT OF LICENSE :

Standard/Premium/Enterprise/All-Inclusive version after you have purchased the Standard/Premium/Enterprise/All-Inclusive license for the plugin, and have received the file of Standard/Premium/Enterprise/All-Inclusive version, you are licensed to install the plugin only into the number of website(s) corresponding to the license you purchased. You may not duplicate the plugin in whole or in part. You may not redistribute, modify, or resell the plugin in any way without the written permission of Xecurify Inc. You may not rent, lease, or lend the plugin. You may not use the plugin in any other plugin or application that competes with the products and services of Xecurify Inc.

Your purchased licenses are perpetual and include 12 months of maintenance (version updates, security fixes, compatibility updates, etc). After 12 months, you need to renew your maintenance for the next 12 months at 50% of the license cost available at the time of renewal to get regular updates & support.

2. YOUR MEMBERSHIP :

During your purchase, we will create an account for you in our membership area. You must keep your login credentials secret. You may not distribute, give away, lend or re-sell it. We reserve the right to monitor the levels of your membership activity and take any necessary action in the event of abnormal usage being detected.

After generating a license that is linked to the domain of the JOOMLA instance, so if you have the dev-staging-prod type of environments and you want to activate the plugin on all the environments simultaneously then you will require 3 licenses of plugin, one for each (You can avail additional discount on pre-production environments). 3. VERSION CHECK AND REGISTRATION :

Service Provider automatically checks for updates to its core and all installed themes and plugins. After you have purchased the Premium License, you will be provided with a unique license key. By entering your license key and registering the domain with the plugin, you can update the plugin in your Service Provider's dashboard. You must keep your license key secret. You may not distribute, give away, lend or re-sell it. We reserve the right to monitor the levels of your key usage activity and take any necessary action in the event of abnormal usage being detected. * The word "Service Provider" means **JOOMLA**.

4. PRIVACY TERMS :

Xecurify does not store or transfer any data, but in some cases depending on the service of the plugin, Xecurify uses the information collected from users. For example, your phone number and email address are used to send the one time passcode for 2FA plugin. For Risk Based Authentication information like device type, location, IP address and time is required to identify the user and grant access based on the risk.

All data provided are stored with miniOrange which can be accessed through our site <https://login.xecurify.com/moas/login> where the user's account is created while using the Xecurify plugin.

Xecurify stores the license information which is specific to each customer and based on the plans.

This information is solely used to provide the services to customers/users.

The other personal information like email address, phone number, company information is used for the purpose of billing and license information only.

5. RESTRICTIONS :

Prohibition on Reverse Engineering, Decompilation, and Disassembly. You may not reverse engineer, decompile, or disassemble the plugin in any way without the written permission of Xecurify Inc.

6. PROHIBITED USE :
